

**MINUTES of REGULAR MEETING

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on November 15, 2016. Mayor Wilkerson commented about the activities of the Internal Auditor and Audit Committee. Commissioner Denning, a member of the Audit Committee, also remarked about the work of the group as well as that of the Internal Auditor and Finance Department.

DeFebbo thanked Mr. Gary for his remarks and recognized Assistant Chief Financial Officers Erin Ballou and Sean Weeks who perform the work and provide the oversight for the accounting and accounts payable functions. Chief Financial Officer Jeff Meisel stated this was the earliest date he could ever remember that the CAFR was released, and he gave credit to Ms. Ballou and Mr. Weeks for their efforts in the process. In response to questions about many residences not having visible house numbers, Chief Hawkins confirmed this technology was useful in pinpointing locations for service calls. Summary of Municipal Order No. 2016 - 248 was read by the Assistant City Manager/City Clerk. Motion was made by Hill and seconded by Parrigin for consideration of said Municipal Order. DeFebbo indicated the City had established a protocol for taking on maintenance of State sidewalks following new construction. Public Works Director Greg Meredith outlined the project for the City to construct new sections of sidewalk on State right-of-way as part of the Sidewalk Construction Program. He reported that in order for the State to provide a permit to construct the sidewalk on its right-of-way, the City had to agree to maintain the sidewalk long-term. He also confirmed the City set a higher standard than the State for sidewalk construction.

Commissioner Denning inquired about the number of existing sidewalks along State right-of-way which were in disrepair and needed to be addressed. DeFebbo indicated the City had previously taken the position it was the State's responsibility to make those repairs and not the City's, unless the City had previously accepted that section of sidewalk by agreement following its construction. City Attorney Gene Harmon confirmed the City has not taken on those repairs primarily because of the cost involved and due to the liability issues since the City did not have immunity like the State or County governments.

For this specific agenda item, DeFebbo pointed out the City was constructing the sidewalk and would assume maintenance in perpetuity. Mr. Meredith confirmed this did not change the relationship or responsibility with the State on its existing sidewalks. Once the discussion ended, a roll call vote was taken.

Chief Financial Officer Jeff Meisel reviewed the growth in City revenues from both the original and expanded sections and the associated disbursements to be made. Mayor Wilkerson reiterated the City retained 20% of the growth and gave back 80% to specified recipients. He also remarked that 80% of the incremental growth in State revenues generated in the same area would be given back as well. Following the discussion, a roll call vote was taken.

Summary of Municipal Order No. 2016 - 252 was read by the Assistant City Manager/City Clerk. Motion was made by Hill and seconded by Parrigin for consideration of said Municipal Order. DeFebbo indicated this was an exciting year in Parks with the various improvements underway and the consolidation of various policy statements would help protect the value of the City's assets. He indicated that several existing policies as well as some new initiatives were combined into one policy document. City Attorney Gene Harmon provided a summary of the proposed policies - a project which had been in the works for a while - which combined and consolidated existing Park policies with some new or emerging issues. DeFebbo stressed the importance of protecting the integrity of such parks as Circus Square and Fountain Square which received significant investments.

In response to questions about abusive or derogatory signage or demonstrations, Mr. Harmon opined the City could not control the content of signs as a constitutional right to free speech. However, he confirmed rental of the park facility would be required for sign displays and the signs

must be attended at all times. Parks and Recreation Director Brent Belcher responded to questions about rental fees for the use of park amenities by private instructors. Mayor Wilkerson commented that since this was the first attempt at consolidating policies there may be changes to come. Once the discussion ended, a roll call vote was taken.
