ORDINANCE AMENDING CODE OF ORDINANCES

ORDINANCE AMENDING CHAPTER 2
(ADMINISTRATION) OF THE CITY OF BOWLING
GREEN CODE OF ORDINANCES TO REVISE THE
MEMBERSHIP OF THE GREENWAYS
COMMISSION OF BOWLING GREEN AND
WARREN COUNTY

WHEREAS, the City of Bowling Green and Warren County created the Greenways Commission of Bowling Green and Warren County; and,

WHEREAS, the membership of the Commission currently includes one member from Warren County Fiscal Court and designated nonvoting ex-officio members; and,

WHEREAS, the Greenways Commission recommended to the Board of Commissioners and Fiscal Court various changes to the Commission composition including the removal of the Fiscal Court appointee and replacing that appointee with an additional citizen appointee approved by Fiscal Court and changes in the nonvoting ex-officio membership.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

1. Chapter 2 (Administration) is hereby amended as follows:

2-22 GREENWAYS COMMISSION OF BOWLING GREEN AND WARREN COUNTY.

2-22.01 Created.

The Greenways Commission of Bowling Green and Warren County is hereby created.

2-22.02 Membership, Terms, Vacancies.

a. The Greenways Commission of Bowling Green and Warren County shall consist of twelve (12) members, with each serving a term of three (3) years, ~~or by the term of office held.~~ Members may be reappointed for successive terms. Vacancies shall be filled within sixty (60) days by the appropriate appointing authority as indicated hereinbelow; otherwise the Greenways Commission

shall fill the position for the remainder of that term. The members shall be appointed in the following manner:

~~1. one (1) member from the Warren County Fiscal Court to be appointed by the County Judge Executive, with the approval of Fiscal Court;~~

21. six (6) members appointed by the Mayor, with approval by the Board of Commissioners; and,

32. six (6) ~~five (5)~~ members appointed by the County Judge Executive, with approval by the Fiscal Court.

b. The Greenways Commission shall also consist ~~be composed~~ of ~~a representative of the City Parks and Recreation Department Director or designee, a representative of the County Parks and Recreation Department Director or designee, the City Public Works Director or designee, the County Public Works Director or designee and the Warren County Metropolitan Planning Organization (MPO) Coordinator (BRADD) a representative of the City County Planning Commission, the Operation P.R.I.D.E. Executive Director and the Downtown Redevelopment Authority Executive Director,~~ who shall act as nonvoting ex-officio members.

~~e. The Greenways Coordinator shall be a nonvoting member of the Greenways Commission and shall be present at all of its meetings.~~

2. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.

3. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.

4. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on
