ORDINANCE AMENDING CODE OF ORDINANCES

ORDINANCE REPEALING CHAPTER 2
(ADMINISTRATION), SUBCHAPTER 2-26
(BOWLING GREEN ENTERPRISE COMMUNITY,
INC.) OF THE CITY OF BOWLING GREEN CODE
OF ORDINANCES AND AUTHORIZING THE
DISSOLUTION OF THE CORPORATION

WHEREAS, the City of Bowling Green, Kentucky, was awarded the designation of an Enterprise Community by the United States Department of Agriculture to provide funding to the City for revitalization efforts as outlined in the City's Strategic Plan which was submitted to the Department of Agriculture; and,

WHEREAS, the City of Bowling Green caused the creation of a nonprofit corporation named Bowling Green Enterprise Community, Inc., composed of fifteen (15) members, to oversee this designation as set out in Subchapter 2-26 of the City's Code of Ordinances; and,

WHEREAS, funding for enterprise communities has been eliminated by the Department of Agriculture and there no longer exists any reason for the continuation of this Subchapter and Bowling Green Enterprise Community, Inc.; and,

WHEREAS, it is in the best interest of the City to repeal Subchapter 2-26 and to authorize the dissolution of the Corporation.

NOW, THEREFORE, BE IT ORDAINED by the City of Bowling Green, Kentucky as follows:

1. Chapter 2 (Administration), Subchapter 2-26 (Bowling Green Enterprise Community, Inc.) is hereby repealed in its entirety.
2. The Mayor, City Attorney and all other appropriate City officials are hereby authorized and directed to take all necessary action to dissolve Bowling Green Enterprise Community, Inc.
3. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall for any reason be declared invalid, such declaration of invalidity shall not

affect the validity of the remainder of this Ordinance.

4. All prior Municipal Orders or Ordinances or parts of any Municipal Order or Ordinance in conflict herewith are hereby repealed.

5. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on August 19, 2014, and given final reading on September 2, 2014, and said Ordinance shall be in full force and effect upon signature, recordation and publication in summary pursuant to KRS Chapter 424.
