THE DIVISION IS ALSO RESPONSIBLE FOR REVIEWING THE PLANS SUBMITTED BY CONTRACTORS, ARCHITECTS OR OWNERS FOR ALL STRUCTURES FOR DESIGN COMPLIANCE WITH THE REQUIREMENTS OF THE [KENTUCKY BUILDING CODE](#).

## PLANNING & ZONING

REVIEW PERMITS TO MAKE SURE THEY ARE COMPLIANT WITH ZONING ORDINANCE REGULATIONS, ANY BINDING ELEMENTS THAT MAY OR MAY NOT BE ON THE PROPERTY, AND PLAT RESTRICTIONS.

WE ARE LOOKING FOR BULK OF STRUCTURES ON THE PROPERTY, WHERE THEY ARE LOCATED FROM THE PROPERTY LINE, SIZE AND LOCATION OF SIGNS, SIZE OF ACCESSORY STRUCTURES COMPARED TO PRIMARY STRUCTURES, PARKING REQUIREMENTS FOR ALL MULTI-FAMILY AND COMMERCIAL CONSTRUCTION, LANDSCAPING BUFFER BETWEEN INCOMPATIBLE USES AND VEHICLE USE AREAS FOR MULTI-FAMILY AND COMMERCIAL/INDUSTRIAL CONSTRUCTION, AND ANY OTHER ADDITIONAL INFORMATION THAT WILL BE USEFUL TO PROCESS THE REQUEST.

LICENSE DIVISION MEMBERS REVIEW PERMIT APPLICATIONS TO VERIFY THAT CONTRACTORS, SUB-CONTRACTORS AND PROPERTY OWNERS ARE IN COMPLIANCE WITH OCCUPATIONAL LICENSE REQUIREMENTS. REVIEW PERMIT APPLICATION TO MAKE SURE THE CONTRACTOR PERFORMING THE WORK IS AN ACTIVE, LICENSED CONTRACTOR IN GOOD STANDING WITH THE CONTRACTORS LICENSING BOARD.

CONTRACTOR MUST HOLD A GENERAL CONTRACTORS LICENSE (NOT A SPECIALTY) IN ORDER TO PULL A PERMIT.

NOTE: IN ORDER TO COMPLY WITH OUR OFFICE, THE GENERAL CONTRACTOR MUST MAINTAIN AN ACTIVE LICENSE WITH CURRENT GENERAL LIABILITY INSURANCE AND WORKERS COMP INSURANCE IF APPLICABLE. THEY MUST ALSO HAVE 3 HOURS OF CONTINUING EDUCATION IF THEY ARE UP FOR RENEWAL.
