**PLEASE READ THE FOLLOWING INFORMATION CAREFULLY**

- ❖ Information on this application must be completed by the applicant for each alarm site.
- ❖ A permit must be obtained prior to the activation of an alarm system.
- ❖ It is the responsibility of the applicant to keep all information listed on the alarm permit application current.
- ❖ The initial cost of the permit is \$15.00, payable to the City of Bowling Green.
- ❖ Renewals of permits for businesses are only \$15.00 annually. Renewals of permits for residences are no cost.
- ❖ The permit is valid for one (1) year from issue/renewal date.
- ❖ The permit is not transferable to a new owner or occupant of the permit site.
- ❖ The permit is not transferable to a different location by the permit holder.
- ❖ The permit holder shall conspicuously post the alarm permit sticker at the front entrance of the permit site such that it is reasonably visible from the front of the site.
- ❖ The permit site will be allowed three (3) false Police alarms and three (3) false Fire alarms during a 12 month period as described above without fines imposed.
